The school operating hours are Monday-Friday, 8:00AM to 6:00PM. Monthly tuition is determined based on the program and hours the Student attends, as listed in above table. Ten percent sibling discount (cousin does not count) is applied on lesser tuition. If the starting date of school is not the first business day of a calendar month, the first month tuition will be pro-rata according to the starting day of the school.

Parent(s) agree to pay the School the monthly service fee outlined in above table (or the pro-rata one for the first month). Monthly payment will be collected through ACH withdrawal from your bank account on the first day of each month. A fifty-dollar (\$50.00) fee will be charged for each rejection of the ACH collection.

Parent(s) are responsible for full payment if the Student is absent for partial month for any reasons, such as being sick at home for a few days, taking short vacation or trip for a couple of weeks etc.

INITIAL HERE

Parent(s) are responsible for half monthly tuition if the Student is absent for full calendar month for any reasons, such as international travel etc. The School will reserve the spot for the Student. The full month must be any calendar month, such as January, February, March etc. A written notice, such as an email, is required to be submitted to the School before the first day of the month being absent.

If the Student is picked up late, the parent will be charged late pick-up fee of \$1.00 per minute.

INITIAL HERE

WITHDRAWAL/TERMINATION OF ENROLLMENT

1. If parent(s) choose to withdraw the Student, the unallocated security deposit will become school credit. The school credit could be credited towards the first month tuition of the future enrollment of the Student who enrolls in this enrollment agreement, or the child from the same family, or the child referred by this family. The school credit could also be credited towards summer camp or backup care at RCA. There is no expiration date for school credit. The security deposit is non-refundable.

INITIAL HERE

2. The School reserves the right to terminate a student's enrollment if parent(s):
 - 1) Are late to pay tuition for two consecutive months.
 - 2) Abuse other children, staff, or school property, show disruptive or dangerous behavior.
 - 3) Show no trust and/or respect to RCA service.
 - 4) Other reasons determined by the School.

In most cases, one-month notice will be given prior to termination of enrollment; however, if the behavioral problem is severe, RCA may terminate the Student's enrollment immediately.
