The school operates Monday through Friday, from 8:00 AM to 6:00 PM. Monthly tuition is based on the specific program and attendance hours selected for the Student, as outlined in the table above. A 10% sibling discount is applied to the lower tuition amount (note: cousins do not qualify). A 5% discount is applied for semi-annual payments, and a 10% discount is applied for annual payment. The discounts are stackable. If the Student's start date is after the first business day of the month, the tuition for the first month will be prorated accordingly.

Parent(s) agree to pay the School the monthly tuition amount listed in the table above (or a prorated amount for the first month, if applicable). Monthly payments will be collected via ACH withdrawal from the designated bank account around the first day of each month. Semi-annual payments will be collected on July 1 and January 1, and annual payment will be collected on July 1.

Parent(s) are responsible for full monthly tuition, even if the Student is absent for part of the month for any reasons such as illness, short vacations, or other personal matters.

Parent(s) are responsible for 50% of the monthly tuition if the Student is absent for an entire month for any reason, such as international travel. During this time, the School will reserve the Student's spot. A written notice (e.g., an email) must be submitted to the School prior to the first day of the month the Student will be absent.

A late pick-up fee of \$1.00 per minute will be charged if the Student is picked up after the designated pickup time.

### WITHDRAWAL/TERMINATION OF ENROLLMENT

1. If parent(s) choose to withdraw the Student, any unused portion of the security deposit will be converted into a school credit. This credit may be applied toward the first month's tuition for a future enrollment of the same Student, a sibling or child from the same family, or a child referred by the family. It may also be used toward summer camp or backup care at RCA. The school credit does not expire. Please note that the security deposit is non-refundable.

2. The School reserves the right to terminate a Student's enrollment under the following circumstances:

- 1) Failure to pay tuition for two consecutive months.
- 2) Abusive behavior toward other children, staff, or school property, or any conduct deemed disruptive or dangerous.
- 3) Demonstrating a lack of trust or respect toward RCA's services.
- 4) Any other reason deemed appropriate by the School.

In most cases, a one-month notice will be provided prior to termination of enrollment. However, in cases of severe behavioral issues, RCA reserves the right to terminate the Student's enrollment immediately.
